### The purpose of the course

The course deals with the theoretical background and different areas of project management, covering the characteristics of European Union projects. The emphasis is on the practical enhancement of management skills. It covers the basics of management as well as the field of business-relevant project management techniques, with particular reference to project management cycles, knowledge management, cost and time management, and strategic management. Students will understand why it is important to manage conflicts, risks, and crises in a project and learn the key management techniques they can use to successfully deal with them. I also introduce and explain the concept of project communication. Students will learn how to communicate inside and outside the project. It includes the study and practice of quality assurance, and students become familiar with the legal conditions for projects.

  - crisis management.

6. Dividing the task into parts (WBS)
7. Quality assurance in the project
  - quality control
8. Strategic planning
  - Strategic management.

### Educational methods

Regular attendance, active participation in class work, completion of in-class assignments/ tasks are required. Final grades will be based on an end-term exam. Students must hand in a written assignment on understanding how to prepare a project plan and a strategic planning of a project.
